Enclosed for filing is the 7th revision of Sheet No. 5 to Alpine Transportation Company's (ATC's) Tariff No. 538 to be effective January 1, 2008. ATC will also make a filing with the Federal Energy Regulatory Commission (FERC) today, November 30, 2007 requesting a similar applicable interstate rate to be effective January 1, 2008. The new rate will result in an increase to \$.69/bbl.

The calculation of the rate was determined in accordance with the Settlement Agreement approved by the Regulatory Commission of Alaska (Commission). An original and ten copies of the Cost of Service Summary, in envelopes marked "Confidential" pursuant to Section I-5 of the Alpine Settlement Agreement, are attached. One copy of the disk showing the calculation, also marked "Confidential" pursuant to Section I-5 of the Alpine Settlement Agreement is attached in a similarly marked envelope.

ATC respectfully requests that the tariff filing be allowed to take effect on January 1, 2008, the same date as its FERC rates. ATC shippers as well as state agencies will be notified of this filing via email.

ATC requests that the Regulatory Commission of Alaska waive the applicable statutory filing period under AS 42.06.390 and 3 AAC 48.300(a)(c) for good cause


